ARTICLES OF INCORPORATION

OF

COMPUTER RENTALS OF CENTRAL FLORIDA, INC.


The undersigned incorporator(s) for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the corporation is COMPUTER RENTALS OF CENTRAL FLORIDA, INC., a Florida Corporation (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is: 8150 Cleary Boulevard, #1510, Plantation, Florida 33324.
- THIRD:** The Corporation is authorized to issue 100,000 shares of common stock, par value \$.01 per share.


