## ARTICLES OF INCORPORATION OF DOUGHERTY + CHAVEZ ARCHITECTS, P.A. OR DOUGHERTY + CHAVEZ ARCHITECTS, P.A.

The undersigned subscribed to these Articles of Incorporation, are natural persons competent to contract and legally authorized to practice the profession of Architecture in the State of Florida, hereby proceeds to form a professional a professional corporation in accordance with the Florida Professional Services Corporation Act, and hereby adopts the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of this corporation is Dougherty + Chavez Architects, P.A.

### ARTICLE II. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

- 1. To engage in the practice of architecture as a professional service corporation and to provide services incident thereto.
- 2. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.
- 3. The services of this Corporation which consist of the practice of architecture shall be carried out only through officers, employees and agents who are licensed in Florida to render the service of architecture.
- 4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to every other act incidental thereto which is not forbidden by the laws of the State of Florida, by the Rules promulgated by the State of Florida or by the provisions of these Articles of Incorporation.

#### ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 500 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice architecture in the State of Florida.

#### ARTICLE IV. DURATION

The Corporation shall have perpetual existence.

#### ARTICLE V. ADDRESS AND AGENT

The street address of the initial principal and initial registered office of the Corporation is 25 Walter Martin Road, NE, Fort Walton Beach, Florida 32548 and the name of its initial registered is James W. Grimsley. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

#### ARTICLE VI. DIRECTORS

The Corporation shall be managed by a Board of Directors of at least two (2) Directors. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice architecture in the State of Florida. If any officer, shareholder, agent or employee of the Corporation who has been rendering professional service to the public for the Corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then the Corporation shall require him or her to comply with the Florida Professional Service Corporation Act by severing all employment with and financial interest in the Corporation.
