ARTICLE I NAME Gan 1, 1999

The name of this corporation shall be Rosetta's Insurance Agency, Inc.

<u>ARTICLE II</u> PLACE OF BUSINESS

The principal place of business and mailing address of this corporation is 6855 Wilson Boulevard, Suite 5, Jacksonville, Florida 32210.

<u>ARTICLE III</u> <u>PURPOSE</u>

This corporation is being organized for the purpose of provision of insurance services and products engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States of America.

<u>ARTICLE IV</u> CAPITAL STOCK

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this corporation, without first offering such shares for sale to this corporation at the net asset value thereof. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at its registered office address, and open for acceptance by this corporation for a period of fifteen days from the date of mailing. If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.
