ARTICLES OF INCORPORATION
OF
JANSON CONSULTING CORP.

The undersigned, acting as Incorporator(s) of Janson Consulting Corp., a corporation under the Florida General Corporations Act, adopt(s) the following Articles of Incorporation for such corporation:

1. NAME: The name of this corporation is Janson Consulting Corp., having its principal place of business at 225 Cortez Road, West Palm Beach, Florida 33405.

2. DURATION: The period of its duration is perpetual.

3. PURPOSE: The purpose is to engage in an interior design consulting business.

4. CAPITAL STOCK: The corporation is authorized to issue 750,000 shares, all of one class, at .01 par value.



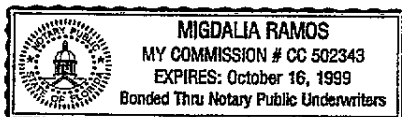


