These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

ARTICLE I

NAME AND LOCATION

EFFECTIVE DATE

DURATION

The corporation shall commence November 16, 1998, and shall have perpetual existence thereafter.

PURPOSE
