ARTICLE 1

NAME

The name of this corporation is: Biggers Management Corporation.

ARTICLE 2

DURATION

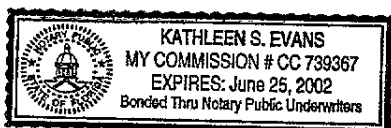
