Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is:

2. The articles of Incorporation are hereby amended by deleting Articles III in its entirety and substituting therefor the following:

"ARTICLE III

Authorized Capital

The corporation is authorized to issue Fifty Million (50,000,000) shares of common stock, with a par value of \$0.001 per share."

3. The foregoing Amendment was adopted by the sole shareholder and sole director of the Corporation on October 30, 2000 in the manner prescribed by Section 607.1006 of the Florida Business Corporation Act.
