March 4, 2002

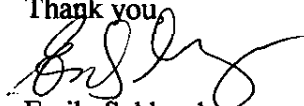
This year, we show no sign of ever receiving our renewal request and it was only during a routine review of our account that we realized we never made payment to you. It was never our intention to be late.
