ARTICLES OF INCORPORATION
OF
DEO, INC.

The undersigned subscriber to these Articles of Incorporation, Daniel E. Ott, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I
CORPORATE NAME

The name of this Corporation is DEO, INC. The principal office and mailing address of the corporation is 22113 Seashore Circle, Estero, Florida 33928.

ARTICLE II
DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

ARTICLE III

BY-LAWS


The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders in the manner provided by the laws of the State of Florida.


