**ARTICLE I. CORPORATE NAME**

The name of this corporation is SUPERIOR BUSINESS CONSULTANTS, INC..

**ARTICLE II. NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.
