ARTICLES OF INCORPORATION

98 NOV 18 AM 8:20

ARTICLE I - NAME

The name of this corporation is *TUBOLOCK, Inc.*

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the principal office and the mailing address of the corporation shall be
155 East Lake Brantley Road, Longwood, Florida 32779.

ARTICLE III - CAPITAL STOCK

The total number of shares of capital stock which the Corporation has the authority to issue is ONE HUNDRED AND FIFTY (150) shares, which shall consist of ONE HUNDRED (100) shares of Class A Voting Common Stock with a par value of ONE DOLLAR (\$1.00) per share, and FIFTY (50) shares of Class B Non-Voting Common Stock with a par value of ONE DOLLAR (\$ 1.00) per share. Each holder of Class A Voting Common Stock shall have one vote with respect to each share of such stock held by him or her of record on the books of the Corporation on matters voted upon by the shareholders. Each holder of Class B Non-Voting Common Stock will be afforded no voting rights but shall have all other rights of a holder of common stock, including rights to a proportionate share of dividends and other distributions made on account of common stock of the Corporation. It is hereby approved and adopted as the certificate to represent shares of stock of the Corporation with the additional wording

"THE TRANSFER OR ENCUMBRANCE OF THE SHARES OF STOCK REPRESENTED BY THIS CETIFICATE IS RESTRICTED UNDER THE TERMS OF A SHAREHOLDERS' AGREEMENT, TOGETHER WITH ANY AMENDMENTS THERETO, A COPY OF WHICH IS ON FILE AT THE OFFICE OF THE CORPORATION."

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 155 East Lake Brantley Road, Longwood, Florida 32779, and the name of the initial registered agent of this corporation at that

address is Mr. Clifford Rees Morgan II.

ARTICLE V - INITIAL BOARD OF DIRECTORS

This corporation shall have One (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the corporation, but shall never be less than one (1). Additional members of the Board of Directors will be elected at the Initial Meeting. Tubolock, Inc will be governed not by its Board of Directors but by its Shareholders as outlined in its By-laws and Shareholders Agreement. Tubolock, Inc Shareholders Agreement will be defined and agreed upon at the Initial Meeting. Major decisions and policy as outlined in the Shareholders agreement will require a majority affirmative vote by its Class A voting stock. 
