subject to this reservation.


**ARTICLE XIII**



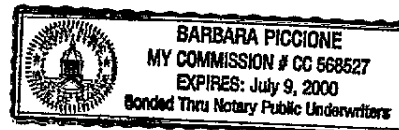
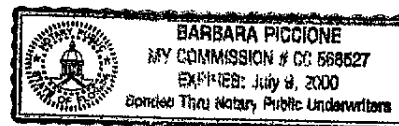
