**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of **MARYBETH McDONALD, P.A.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:
