ARTICLES OF INCORPORATION OF Mackintosh Web, Inc.,

The undersigned incorporator(s), for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation

ARTICLE I

Name. The name of the Corporation shall be Mackintosh Web, Inc.
