ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is INNOVATE REPRESENTATION SERVICES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on November 16, 1998.






