ARTICLE I - NAME

The name of this Corporation is NORTH PALM BEACH COUNTY ONCOLOGY -  
HEMATOLOGY ASSOCIATES, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

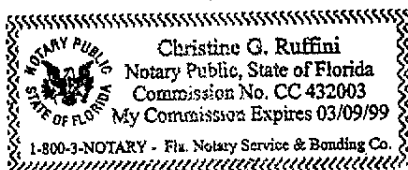
