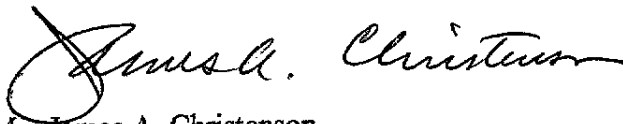

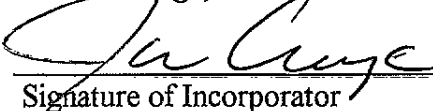
### ARTICLE V PURPOSES

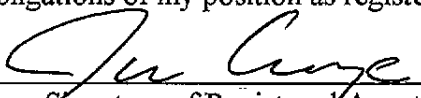

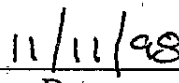
