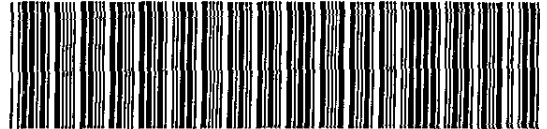

1. The text of **ARTICLE I: NAME** of the articles is amended to:


