

**ARTICLES OF AMENDMENT TO THE ARTICLES OF THE INCORPORATION  
OF  
COBRATEX, INC.**

The undersigned, being the sole incorporator of COBRATEX, INC., a corporation under the Florida General Corporation Act, prior to the issuance of any shares in the corporation, and pursuant to §607.1005, Fla. Stat. (1998) adopts the following Articles of Amendment to the Articles of Incorporation of COBRATEX, INC.

1. This amendment is authorized by §§607.1005 and 607.1006 Fla. Stat. For the purpose of the forgoing, the Secretary of State is informed that:

a. The name of the corporation is changed to EASTERN COAST TEXTILES, INC. Article 1 of the original Articles is accordingly amended to reflect the name change.

b. The text of the other amendment is as follows: Article 6 of the original articles of incorporation are amended to read:

**6. The principal place of business of the corporation shall be located at: 1172 South Dixie Highway, Coral Gables, Fl. 33146**

c. The amendment was adopted August 12, 1999.

d. These amendments do not require shareholder approval and accordingly, no shareholder approval was sought.


