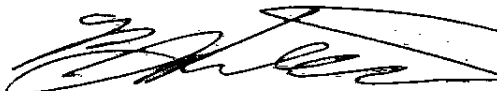

1. The name of the corporation to be dissolved is INTERCONTINENT SUPPLIERS, INC.

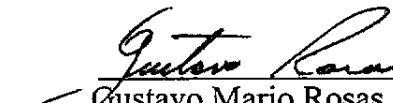
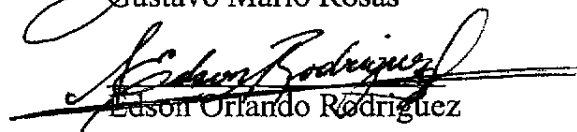
2. The date of issuance of its Articles of Incorporation is November 16, 1998.
