#### ARTICLES OF INCORPORATION OF JAFFE PROPERTY MANAGEMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

#### ARTICLE I NAME

The name of the Corporation is Jaffe Property Management

#### ARTICLE II DURATION

The term of existence of the Corporation is perpetua

#### ARTICLE III NATURE OF BUSINESS

The nature of the business to be conducted by the Corporation is:

- To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act;
- To engage in the management, purchase, sale, and leasing of real property; and
- To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
