ARTICLES OF INCORPORATION OF JANEX TRADING CORPORATION

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the Laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is JANEX TRADING CORPORATION

ARTICLE TWO - BUSINESS AND PURPOSE

The corporation is organized for any lawful purpose permitted under the Laws of the State of Florida.


