ARTICLE I. NAME: The name of the corporation shall be DRD PRODUCTIONS, INC.

ARTICLE II. ADDRESS: The principal place of business of this corporation shall be: 3107 Wyoming Avenue, Tampa, Florida 33611.

ARTICLE III. NATURE OF BUSINESS: The purpose of this business is to engage or transact in any or all lawful activity or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK: The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$.001 per share.

ARTICLE V. ADDRESS; REGISTERED AGENT: The street address of the initial registered office of the corporation shall be: 3107 Wyoming Avenue, Tampa, Florida 33611 and the name of the initial registered agent of the corporation at that address is Russell A. Bruno. I, Russell A. Bruno am familiar with and accept the duties and responsibilities as registered agent for said corporation.
