CAPITAL STOCK



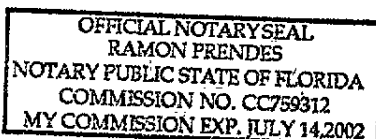


