### **ARTICLES OF INCORPORATION**

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLES I: NAME OF THE CORPORATION

PROTOHYPE GEAR, INC.

The name of the corporation is hereinafter referred to as the "Corporation".

#### ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

#### ARTICLE V: AUTHORIZED SHARES
