THE UNDERSIGNED, FOR THE PURPOSE OF FÖRMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

## ARTICLE I. NAME

THE NAME OF THIS CORPORATION IS D S K FURNITURE REPAIR, INC.

## ARTICLE II. PRINCIPAL PLACE OF BUSINESS
