ARTICLE I -- NAME

The name of this corporation is: **Picasso Finance , Inc.**

ARTICLE XII -- INDEMNIFICATION


The corporation shall indemnify any officer or any former officer to the full extent permitted by law.



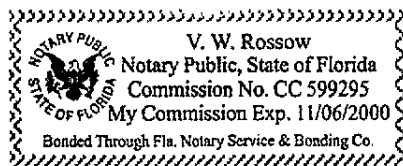
