The name of this corporation shall be Coconut Telegraph Marketing, Inc.

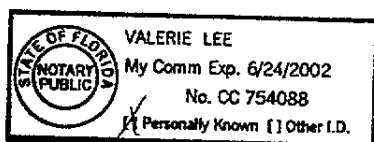



