The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles Of Incorporation for such corporation:

ARTICLE I

Name

The name of this corporation is SOUTHERN HOSPITALITY, INC.

ARTICLE II

Duration

The period of existence of the corporation is perpetual.

ARTICLE III

Purpose

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV

Principal Office and Mailing Address
