**ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Dixie Plazas of N.W. Florida, Inc.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on the date of filing.

ARTICLE IV - CAPITAL STOCK
