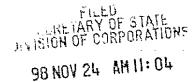

ARTICLES OF INCORPORATION OF PRAISE / MARLIN AUTO RENTAL, INC.

ARTICLE I - NAME

The name of this corporation is Praise / Marlin Auto Rental, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE
