#### ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, subscriber to these Articles of Incorporation, natural persons, competent to contract, join together to form a corporation under the laws of the State of Florida; and further agree to the following conditions of şaid corporation.

#### **ARTICLE I - NAME**

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing with the date of acknowledgment of these Articles.

## **ARTICLE III - PURPOSE**




