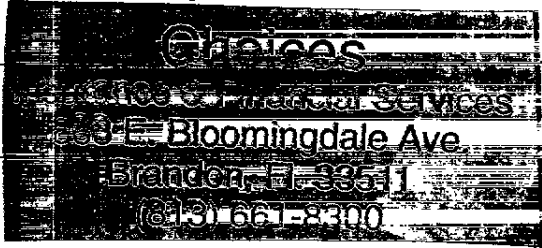

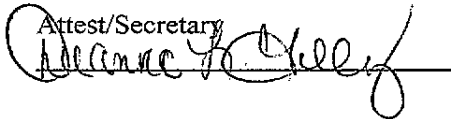
Article I

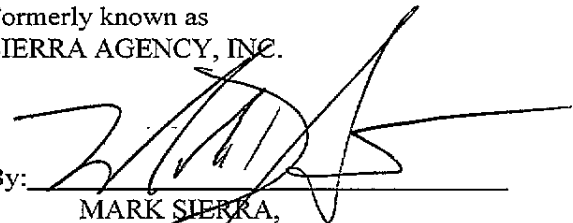
The name of the Corporation shall be changed from SIERRA AGENCY, INC., to CHOICES INSURANCE & FINANCIAL SERVICES, INC.
