I, the undersigned, hereby make, subscribe and acknowledge this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.

The name and address of the person signing these Articles is Rick Peterson whose address is 4801 S. University Dr., Davie, FL 33328.


ARTICLE VIII - INDEMNIFICATION



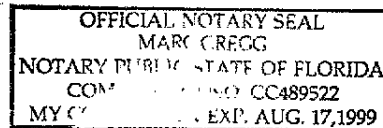
