

### ARTICLE VIII. BY-LAWS

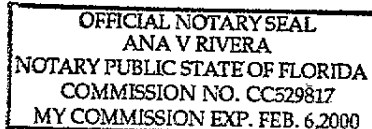


