ARTICLES OF INCORPORATION OF

FLORIDA DESIGN NETWORK, INC.

The undersigned, acting as an incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - CORPORATE NAME

The name of the corporation shall be: FLORIDA DESIGN NETWORK, INC.

ARTICLE II – DURATION

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III - NATURE OF BUSINESS
