OF AMERITEL COMMUNICATIONS SYSTEMS, INC.**


Pursuant to the provisions of §607.1003 (6), Fla. Stat., the Florida Business Corporation Act Ameritel Communications Systems, Inc. does hereby amend its Articles of Incorporation as follows:

1. The name of the corporation is Ameritel Communications Systems, Inc.
2. This Amendment to the Articles of Incorporation was duly approved and adopted, in accordance with §607.1003, Fla. Stat., on June 17, 1999, by written consent without a meeting by of the holder of a majority of the Corporation's issued and outstanding Common Stock, as permitted by §607.0704, Fla. Stat., upon the recommendation of the Corporation's Board of Directors, being sufficient in all respects for approval hereof.
3. Article I of the Corporation's Articles of Incorporation be, and it hereby is, amended to change the name of the Corporation to PAWNAMERICA.COM, INC.
4. Except as provided herein, the Articles of Incorporation, as previously amended, of the Corporation shall be and remain unchanged.


