

ARTICLES OF INCORPORATION OF  
SUNSET FAMILY RESTAURANT, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be SUNSET FAMILY RESTAURANT, INC.

The principal address of the corporation at the time of incorporation is 4575-79 Pine Island Road, Sunrise, Florida 33351

ARTICLE II. DURATION

The duration of this corporation is perpetual, unless dissolved according to law.
