#### Section 1244 Stock

The incorporator, Subscribers and Directors of the corporation intend that all stock shall be issued pursuant to Section 1244 of the Internal Revenue Code of 1954, as amended.

#### ARTICLE V

#### Unissued or Treasury shares

Unissued or treasury shares may be offered to a nonshareholder of the corporation only after all the existing shareholders have refused to purchase the shares offered.
