ARTICLES OF INCORPORATION

OF

FLEUR DE LYS DECORS, INC.



The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME AND PRINCIPAL PLACE

The name of the corporation is Fleur de Lys Decors, Inc. The principal place of business of the corporation shall initially be 8473 Bay Colony Drive, Suite 1701, Naples, Florida 34108.

ARTICLE II

DURATION

The corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The corporation is organized for the purpose of providing interior decorating services to the community and to transact any or all lawful business.

ARTICLE IV

CAPITAL STOCK
