ARTICLES OF INCORPORATION

OF GUERNICA ENTERPRISES, INC.

The undersigned subscribers to these Articles of Incorporation hereby form a corporation under the Florida Business Corporation Act.

<u>ARTICLE I</u>

Name of Corporation

The name of the corporation is: GUERNICA ENTERPRISES, INC.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purpose

The general purposes for which the corporation is organized are:

- I. To operate a seasonal Cantina
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- 3.
