ARTICLES OF INCORPORATION

OF

TROOP ASSOCIATES, INC.

ARTICLE I - NAME:

The name of this corporation is: TROOP ASSOCIATES, INC. hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon EFFECTIVE DATE January 1, 1999.
