ARTICLES OF AMENDMENT
of
NETLOCATE, INC.

Pursuant to **Florida Statutes Section 607.1006**, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:


1. Article IV, Capital Stock is hereby amended to read as follows:

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 100,000 shares of common voting stock. None of the shares of the Corporation may be issued to anyone other than an individual who has been approved as a shareholder by the Board of Directors.

2. The foregoing amendment was adopted by the incorporators on March 1, 1999.

3. The amendment was adopted by the incorporators before the issuance of shares; thus, shareholder action was not required.


