The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE 1. - NAME

The name of this corporation is:

ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To initially provide telephones in business locations for the publics use, to engage in all other aspects of the telecommunication market, to engage in the sales, domestically & for export of any & all commercially traded products & to engage in any & all other functions, services and/or activities determined as necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
