**ARTICLES OF INCORPORATION**  
**OF**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is GOLD COAST MARKETING GROUP, INC.

**ARTICLE II**

The existence of the corporation shall begin on the date of filing of these articles.

**ARTICLE III**

The street address of the principal office of the Corporation is 1920 East Hallandale Beach Blvd., Suite 700, Hallandale Beach, Florida 33009.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100 at no par value, all of which shall be Common Shares. 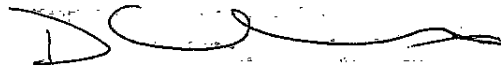

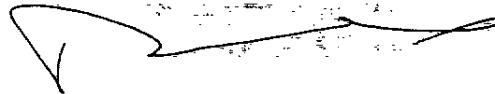
