ARTICLES OF INCORPORATION
OF
JOHNSON, BAUGHAN & COLEMAN, P.A.

In compliance with the requirements of F.S. Chapters 607 and 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional service corporation.

ARTICLE I

The name of the corporation is JOHNSON, BAUGHAN & COLEMAN, P.A.

ARTICLE II

The existence of the corporation shall begin on November 23, 1998.

ARTICLE III

The street address of the principal office of JOHNSON, BAUGHAN & COLEMAN, P.A. is 1290 Federal Highway, Rockledge, Florida 32955.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is FIVE HUNDRED (500), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. All shareholders shall have to comply with the requirements of Chapter 621, Florida Statute.

ARTICLE V

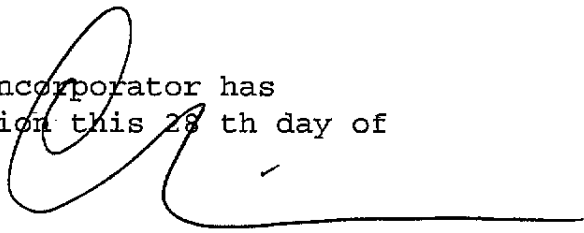

JOHNSON, BAUGHAN & COLEMAN, P.A. shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

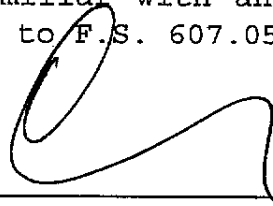
