ARTICLES OF INCORPORATION
OF

ARTICLES I

The name of this corporation is Accent Contractors, Inc..

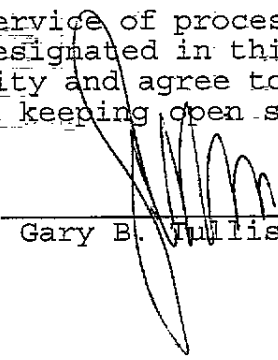

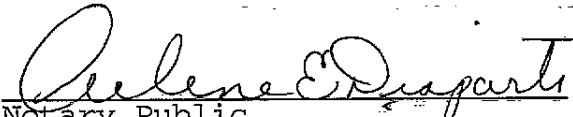
