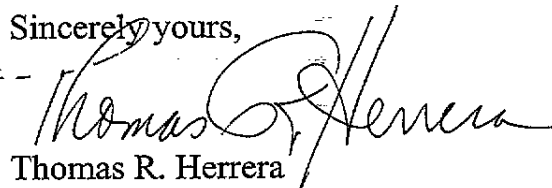

**ARTICLES OF INCORPORATION
OF

ARTICLE I.

CORPORATE NAME

The name of the corporation shall be:

ARTICLE II.

NATURE OF CORPORATE BUSINESS

The corporation may engage in any business as allowed under the laws of the United States and
