Name

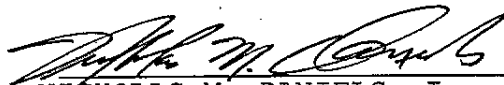
This corporation shall initially have five (5) directors. The number of directors may be increased or decreased from time to time

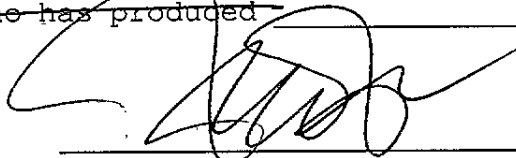
