

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is UNDERHILL PAINTING, INC.

ARTICLE II - PRINCIPAL OFFICE/MAILING ADDRESS

The principal office of this corporation is 1211 SW 25th Way, Boynton Beach, FL 33426.

ARTICLE III - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to issue is Five Hundred (500), which shares shall be common stock having a one dollar (\$1.00) par value.
